SARETI - the South African Research Ethics Training Initiative is a research ethics training programme funded by a grant from the Fogarty International Center and the US National Institutes of Health (http://www.fic.nih.gov) SARETI provides Masters-level training in research ethics and non-degree training for members of African Research Ethics Committees, researchers and other stakeholders. The SARETI curriculum is multidisciplinary, combining skills and resources from the University of KwaZulu-Natal and the University of Pretoria. SARETI provides advanced training in research ethics relevant to the health and research needs of the African continent, and hopes to promote and foster African scholarship in research ethics.

This, our third newsletter, provides an overview of the activities of the end of our second and early phase of our third years of activity, and continues as part of a series of periodic updates and communications about SARETI.

1. SARETI SCHOLARS AND FELLOWS

1.1. CURRENT SCHOLARS AND FELLOWS

Between May and August 2004 we recruited our third group of SARETI Scholars and Fellows. We received 48 applications from 13 African countries, as well as applications from Iran and the Philippines. Our 2005 group comprises 3 women and 4 men. Selection was merit based.

1.2. PAST SCHOLARS AND FELLOWS

SARETI Scholars and Fellows on return home have been active in improving health review systems in their home countries. To date:

- Our four SARETI Scholars attended the June 2004 summer programme in international health research ethics at the Bloomberg School of Public health, Johns Hopkins University, and attended the Kennedy Institute of Ethics Intensive Bioethics Programme.
- The 2004 SARETI MPH students attended a 2-day "Ethics Roundtable" at the Wellcome Trust funded Africa Centre For Health and Population Studies, Mtubatuba, at the invitation of Dr Mike Bennish. This regular event, of which Dr Wassenaar is a co-facilitator, focuses on research protocols and their ethical implications of a rural health research centre.
- Of the 2003 Masters (MPH) Scholars, Ms Joyce Ikingura (Tanzania) has submitted the final version of her research thesis for supervision prior to examination. Ms Ikingura has completed and passed all other components of the MPH. Mr Owen Mapfumo plans to have his thesis submitted by June 2005, delayed because of adverse circumstances in Zimbabwe.
- Of the 2004 Masters (MPH) Scholars, Drs O Manafa (Nigeria) and A Nyika (Zimbabwe) have submitted
 final drafts of their research theses for supervision prior to final examination. Ms Rose Musesengwa
 (Zimbabwe) has received ethics approval and is about to commence data collection, and Ms A Keita
 (Mali) has commenced data collection but is continuing some coursework in 2005 after changing to an
 MPhil from the MPH.
- All three 2004 SARETI Fellows (Dr M Limo, Dr W Oyibo & Dr H Diallo) successfully completed all their SARETI coursework modules and remain in regular contact and have either continued to serve on RECs, or work in an ethics advisory capacity, or activated research ethics training activities in their home countries (Kenya, Nigeria and Burkina-Faso, respectively). We are in regular contact with these Fellows and those of 2003. Dr Diallo is working on two papers with SARETI staff.
- Collaborative writing projects between Fellows, Scholars and faculty are ongoing.
- We remain in regular contact with the 2003 Fellows, two of whom were accepted for Masters (MPH training) in 2004 (Dr O Manafa and Dr A Nyika).
- On completion of his coursework, Dr A Nyika was awarded a prestigious post-doctoral Fellowship at the Centre for the AIDS Programme of Research in Africa (CAPRISA, funded by NIAID, NIH & DHHS) at UKZN where he is working with Dr Salim Abdool-Karim and Dr J Singh and the CAPRISA ethics team.
- One SARETI Scholar (Dr O Manafa) was nominated on merit to attend the 5th Global Bioethics Forum in Paris, partially funded by SARETI and partially funded by the organisers of the Forum (with kind assistance of Dr F Hirsch).
- On completion of her coursework, Dr O Manafa has been appointed to assist WHO/TDR in Geneva (with Dr J Karbwang) in a research ethics capacity.
- Ms J Ikingura (MPH, 2003) has continued to assist the Tanzanian national REC as its general secretary, and attended an NIH advanced research ethics workshop in Zanzibar in December 2004. Her research thesis will be ready for examination in April 2005.
- Mr Paul Ndebele (SARETI PhD candidate) has successfully defended his PhD proposal and is now a fully registered PhD candidate in the School of Psychology, UKZN. He continues to serve the Johns Hopkins Bioethics programme in an advisory capacity.
- The 2005 Masters students have commenced their SARETI coursework. An introductory basic skills
 workshop was run for these students by Drs Wassenaar and Mkhize, which was positively evaluated by
 the new students.
- Four 2005 SARETI non-degree Fellows have been selected and are due to commence their coursework in May 2005. One Fellow declined his place due to a serious MVA; his place has been filled by another candidate but he will be offered a place in 2006 if he is able to accept it.
- Further ('self-funded') students from other degree courses (MSc Clinical Epidemiology, and MMed Community Health & Nursing) participated in various SARETI modules in 2004.

Masters Scholars 2004-2005

Ms Awa Keita

Ms Keita is currently completing her SARETI coursework and developing her research work. She is due to complete her coursework at the end of May 2005.

Ms Rosemary Musesengwa

Since returning to Zimbabwe after completing her MPH coursework in December 2004, Ms Musesengwa has trained research team members for the University of Zimbabwe and University of San Francisco Collaborative project. She attended an ethics training workshop organized by the Medical School, and facilitated at a research ethics training workshop for scientists from the SADC region. Ms Musesengwa is involved in running the MRCZ, reviewing proposals, monitoring four clinical trials in the field, and assisting in developing a research ethics module for the MMed (Medical Ethics) students at the medical school. She is currently conducting her research project on Perceptions of Benefits of Research by Participants of a Clinical Trial. She attended the EU/University of Bergen/SARETI research ethics training workshop in Durban earlier this year, and has recently returned from attending the 6th Global Bioethics Forum in Malawi where she introduced one of the case discussions and acted as a rapporteur.

Dr Ogenna Manafa

Dr Manafa completed her SARETI Fellowship certificate in 2003 and was subsequently accepted into the SARETI MPH (Health Research Ethics) programme in 2004. She completed and passed all her modules. Her thesis is near completion, and she is expecting to submit by the end of April this year. Dr Manafa reports that the SARETI programme has improved her depth and scope of knowledge in bioethics. Through the experience she gained she was able to establish an Ethics Committee in her home institution in Nigeria. She is currently working for the WHO/TDR in Geneva and attended the 6th Global Bioethics Forum in Malawi where she acted as a rapporteur.

Dr Aceme Nyika

Dr Nyika completed a six-month research ethics Fellowship with SARETI in October 2003. He was then awarded a SARETI scholarship to study for a Master of Public Health (MPH) degree in 2004. He has completed both coursework and research project for the MPH. He is finalizing his MPH thesis entitled "Informed consent: Impact of relationships on decision-making process of women in Harare, Zimbabwe". Currently, he is a research Fellow with the Center for the AIDS Program of Research in South Africa (see www.caprisa.org).

Fellows 2004

Dr Abdoulave Diallo

Dr Abdoulaye (Hama) Diallo commenced a Fellowship with SARETI in March 2004, at the University of Pretoria. He completed his Fellowship in May 2004. Since then, Dr Diallo has been involved in the following ethics-related activities: 1) he has drafted two workshop proposals for training in health research ethics for IRB members and rearchers in Burkina Faso. 2) From November to December 2004, Dr Diallo registered for a course on Clinical Trials and Infectious Diseases at Institute Pasteur of Paris with two modules focused on ethics in Clinical Trials management. 3) He is currently in discussion with a colleague from Institute Pasteur (Paris) and the Head of his research institute to plan an international workshop in ethics that will take place in Bobo-Dioulasso (Burkina Faso). He was requested to draft a communication, and will do a presentation on the current situation of health research ethics in Centre Muraz with an outline of the difficulties met by its IRB since its implementation. 4) Dr Diallo is also currently working on two articles in collaboration with SARETI's Exec: One on the "Current situation of health research ethics in Burkina Faso" and the other on "Health priorities in Africa: Case of Burkina Faso".

Dr Moses Limo

Dr Limo is currently Director, Graduate School, Egerton University, involving 1303 postgraduates in 8 faculties. He is also the Vice-Chairman, Biochemical Society of Kenya. Since his SARETI training, he has continued to teach biotechnology ethics and other aspects of bioethics to undergraduate students and is currently planning a postgraduate bioethics course with collegues. As a member of Egerton University Research Committee he reviews research and funding proposals ethically and scientifically.

Dr Wellington Oyibo

Dr Oyibo attended the 6th Global Bioethics forum in Malawi and met with SARETI staff. He reports that he is preparing an article for publication. Dr Oyibo is also involved in the Fogarty West African Bioethics Initiative (see http://www.westafricanbioethics.net/index.html). He also attended the WHO/TDR/World Bank consultative meeting on biotechnology and ethics (ELSI) in Ibadan, Nigeria in March 2005.

Masters Scholars 2005-2006 Ms Janelisa Musaya

Ms Musaya is a researcher from Malawi and on completion of her SARETI training plans to assist in the FIC Bioethics programme at the University of Malawi with Dr Mfutso-Bhengo. Her research topic is to be confirmed by April 2005. She attended the EU/Bergen/SARETI research ethics workshop in Durban in February 2005.

Mr Bornwell Sikateyo

Mr Sikateyo (from Zambia) was formerly a Fellow of the Johns Hopkins Fogarty Bioethics programme, and has been accepted for a SARETI MSocSc (Research Ethics) Masters programme in 2005. His research topic is to be confirmed by April 2005. He attended the 6th Global Bioethics Forum in Malawi in March 2005.

Dr Firew Wubiee

Dr Firew Mekonnen Wubiee is a medical practitioner and is a lecturer in public health at University of Gondar, Ethiopia. He served as a chair of the Institutional Review Board (IRB) at this university for nearly two years. He reports that apart from his exposure in the ethics committee, there is no formal training in the medical school curriculum in clinical and research ethics. As a result, he began to look for opportunities for ethics training to equip himself with the basis and practical procedures. He states that SARETI has transformed him from a layperson to a reasonable ethics thinker. Dr Wubiee feels that the SARETI teaching method is tailored so that students are given exposure to the university ethics committee and are able to evaluate research proposals. He has found the special programme on conflict management, time management and critical thinking classes with SARETI staff particularly helpful in facilitating his learning.

2. SARETI PROGRAMME ACTIVITIES

- SARETI hosted a Research Ethics Training Workshop sponsored by the European Union and the University of Bergen in Durban, South Africa in February March 2005. This was attended by 65 delegates from 17 African countries. Presenters included Drs Reidar Lie, Ezekiel Emanuel, David Wendler, Drs Wassenaar and Mkhize and Kruger of SARETI, and several European bioethics experts, including Drs Emilio Mordini and Francois Hirsch. The selection of attendees was based on SARETI training applicants who had not secured full masters scholarships or fellowships. All course logistics and arrangements were coordinated by SARETI, and the course attained high satisfaction ratings by attendees.
- It is clear that SARETI is becoming well known as a provider of medium and long-term research ethics training on the African continent. This is evident from the increasing numbers of events which SARETI faculty are invited to attend, and by the diversity and quality of applications for SARETI funding.
- SARETI has also been nominated as a provider of research ethics training for future staff at the Wellcome Trust funded KEMRI site in Kilifi, Kenya (PI: Dr K Marsh).
- SARETI has been nominated as a provider of research ethics scholarship training for the African Malaria Network (AMANET) (PI: Dr W Kilama).
- SARETI has continued to contribute to research ethics library holdings at the Universities of KZN and Pretoria. Subscriptions have been taken on the Hastings Center Report and IRB, for use at SARETI Journal Clubs with students.
- With the dedicated and skilled help of our two administrators, Ms D Marais, and Ms N Khan, we have continued to improve and refine SARETI's administration and systems. We now have a well-developed student 'Welcome pack', in addition to other programme resources that assist with student and programme administration.

Professor Mariana Kruger:

SARETI supported Dr M Kruger's attendance at the OHRP' workshop *Strategies for protection of Human Research subjects globally* for IRB members held in the US. She presented papers at the 36th SIOP meeting in Oslo and at the *Kidz-n-All* Conference in Cape Town on research ethics and childhood cancer. Dr Kruger completed an MPhil (*cum laude*) in 2004 on the topic of ethics education in medical undergraduate students and the paper was presented at the SA Association for Health Educators, 2005. Dr Kruger has been appointed to the advisory committee of HEARD at UKZN to consult on the ethics of research with children, and continues to serve on the RECs of the University of Pretoria and the SA Medical Research Council. She was invited to attend the EFGCP Annual Conference in Brussels to examine the proposed EU regulation on medicinal products for paediatric use. She currently does both GCP (Good Clinical Practice) and research ethics training for postgraduate medical students and coordinates the undergraduate ethics education at the Faculty of Health Sciences, University of Pretoria. Dr. Kruger is the PI of the following clinical trial: Protocol BI 1100.1413 Open-label study evaluating the resistance profile of single dose Nevirapine when combined with a 4 or 7day course of Combivir compared to single dose Nevirapine for prevention of mother to child transmission (Boehringer Ingelheim).

• Dr Theresa Rossouw:

Dr Theresa Rossouw attended a 3-day NIH Workshop for Advanced Ethics Training in Zanzibar in December 2004. She was appointed Clinical Head of ARV (Anti-retroviral) Clinic at Pretoria Academic Hospital as from 1 January 2005. She has also been appointed as an extraordinary member of the Department of Family Medicine at the University of Pretoria. She currently does GCP (Good Clinical Practice) training at Pretoria Academic Hospital and at the Faculty of Health Sciences, University of

Pretoria. Topics include ICH-GCP and SA-GCP, and Informed Consent. Dr Rossouw registered for an MPH degree (Biostatistics and Epidemiology track) at the University of Pretoria in January 2005. She is developing a SARETI module for WEB-CT, and has attended a WEB-CT course sponsored by SARETI. Dr Rossouw is also an extraordinary lecturer in the department of Family Medicine, teaching ethical aspects of HIV/AIDS.

Dr Doug Wassenaar:

Drs Wassenaar, Kruger and Mkhize attended the annual FIC programme directors' meeting in Bethesda MD. Dr Mkhize attended at minimal cost to SARETI as he was already in the US at the invitation of PRIM&R. Dr Wassenaar has been appointed to the advisory committees of NIH/FIC Bioethics training programmes in Malawi (PI: Drs T Tomlinson & J Mfutso-Bengo) and Ibadan, Nigeria (PI: Dr C Ademabowo). He presented papers at international research ethics workshops held in Zanzibar (NIH Dept of Clinical Bioethics), Durban (EU/Bergen/SARETI), and Ibadan (WHO/TDR/World Bank. Dr Wassenaar and Dr IJsselmuiden attended the 6th Global Bioethics Forum in Malawi in March 2005, where Dr Wassenaar presented one of the discussion cases. At least 6 SARETI Fellows and Scholars also attended the Forum - no cost to SARETI. Drs Wassenaar, Rossouw and Ms M Stobie attended a lecture by Dr Norman Daniels (On justice) at the Africa Centre, Mtubatuba. Dr Wassenaar has been appointed as an advisor to the research ethics Committee of the Human Sciences Research Council and has also served a period as interim chair of this committee.

• Dr Carel IJsselmuiden:

Dr IJsselmuiden, now a Senior Executive Member, remains in charge of the SARETI module "Ethical Issues in International Collaborative Research", which he taught in August 2004. Dr Rossouw took over coordination of Dr IJsselmuiden's other module entitled "Public Health, Ethics and Human Rights". SARETI co-supported the travel costs of Dr C IJssemuiden who was a keynote speaker at a West African conference initiated by one of our 2003 SARETI Fellows on the use of plants in traditional medicine.
